MEMO

Dear Members,

The Annual General Meeting 2026 was held on Saturday, 25 July 2026. The FBHU Management would like to thank all Union delegates in attendance for their valuable input.

We are pleased to inform you that the **2025 Annual Financial Statements** have been audited and have received an **unqualified audit**.

This outcome confirms that the financial statements present a true and fair view of the FBHU's financial position and have been prepared in accordance with the applicable financial reporting standards.

The FBHU Executive Committee extends its appreciation to everyone who contributed to this achievement and thanks all members for their continued support and commitment to sound governance and financial accountability.

Herewith a summary of decisions taken at the Annual General Meeting - AGM:

1. BIRDAGE LIMIT

Members please note; effective from the Vosburg race, increase of birdage per member from 18 to 20 birds per race for the remainder of the racing season. The dual races bird limit will be 10 birds per race.

2. 2027 FB RING RACE

Following a review of the FB Ring Race, the AGM has resolved that, with effect from the 2027 racing season, only FB rings will be eligible to participate in all FB Races.

Accordingly, all existing and prospective members are required to ensure that their pigeons are rung with FB rings. No exceptions will be permitted.

Members are requested to take note of this resolution and make the necessary arrangements to ensure compliance.

3. ELECTRONIC CANNs

1. All members owning personal CANNs must disclose those CANNs.
2. No CANN's allowed at a member's residence, all CANN's including personal CANN's to be handed over to the Union Race Secretary on the night of basketing for all races and will be returned at ring out.
3. Failing to comply with the above will lead to immediate disqualification.

4. RACE COMMITTEE – CAR BIRD RACE

Basketing for Vosburg:

Basketing Date : Thursday, 30 July 2026
 Liberation Date : Saturday, 01 August 2026

Please note:

1. Ring out will be Sunday, 02 August 2026 at 15h00 but can download clocks from 13h00.
2. All Car Birds arriving on Saturday, 01 August 2026 must be reported to Union Race Secretary an hour after arrival with ring & rubbers' number. All Race Secretaries must report to Board Race Secretary all car birds.
3. No more than 10 ordinary rings to participate in the Vosburg race.
4. Basketing of birds:
 - a. Race 1 – all FB's in first 20 birds.
 - b. Race 2 – all ordinary rings in your first 20 birds.
 - c. Race 3 – all Car birds in your first 20 birds.
 - d. Race 4 – all FB's outside your first 20 birds.
 - e. Race 5 – all Car birds outside your first 20 birds.
5. Each race must have their own entry sheets.
6. All FB's and Car birds are split in two zones.
 - a. Zone 1 - MDU, WCHU, KHPU, KDHU, SHU, GDHU, PDHU, CPHU SPLIT.
 - b. Zone 2 - NSHU, SDHU, MPHU, CFHU, WDHS, BPF, CPHU SPLIT.
7. The following rings are allowed to race in Young Bird races -FB's, MDU, WCHU, KHPU, KDHU, SHU, GDHU, PDHU, BPF, NSHU, SDHU, MPHU, CFHU, WDHS, WPET, PPS, UTOPIA, PETOTREAT, PHSW, PPL, WU, NRHU, ZAEP, BDU, WPHU, SPHU, SSPO, ELITE, FP, BPPD, WYNLAND.
8. All 2026 rings can participate in Young Bird races.
9. Members using Benzing Live can home evaluate but MUST submit their car bird rubbers before ring out cutoff time.
